The Reason Why the Moon Administration Had to Commit Election Fraud

President Moon Jae-in's administration was expecting an impeachment if they did not secure at least half of the seats within the National Assembly through the April 15, 2020 general election.

In 2018, the Moon administration visited China and declared to support the "Chinese Dream." The Chinese Dream is to become a tributary of China by sharing the same faith as China and share their dreams. Thus, declaring pro-China and anti-American sentiments. And, through a constitutional amendment, the Moon administration is attempting to remove the word "free" from the phrase "the basic free and democratic order" which is stated in the Constitution. To remove "free" from the Constitution is to recognize communist ideas such as totalitarianism and socialism. Fortunately, they could not proceed with the amendment due to the opposition party's objection. However, the Moon administration already removed the word "free democracy" from all middle and high school textbooks.

In order to form a country like the Chinese Communist Party, the Moon administration is establishing the Corruption Investigation Office for High-ranking Officials (CIO) and to share the Prosecutors' Office's authority to the CIO and the police. The CIO is modeled after the Chinese Communist Party's Central Commission for Discipline Inspection, and the role of the police will change into the likes of the PRC's Ministry of Public Security. They are also trying to eliminate individual ownership of property and establishing property rights like the Soviet's Socialist Union. A prime example of such is disallowing private kindergartens' owners from using the profit from their own kindergartens and have such private property managed by the government. Another example is a never-heard-of policy, "Stewardship Code," which uses the National Pension Funds (NPF) and it allows the state to intervene in corporate decision-making where the NPF holds stocks in. This caused the Chairman of Korean Air to be unable to serve another term and was released from the company. In addition, the Moon administration closed down special-purpose private high schools, infringing upon remarkable students' rights to receive education. They arrested a civilian who called Moon Jae-in a communist and a reporter who was investigating the government's corruption. The prosecutors who were investigating the government's corruption were transferred to rural positions. There are sufficient reasons to impeach the Moon administration including infringing upon judicial independence, the right to one's private property, the right to receive appropriate education, taking command of the media and infringing upon the freedom of expression. In addition, numerous corruption scandals have emerged. As a result, on October 3, 2019, 3.5 million citizens gathered at the Seoul Gwanghwamun Plaza and cried out for the impeachment of Moon Jae-in.

If the Moon administration had lost the April 15, 2020 general election, the socialist revolution they had prepared for decades would have come to an end. The word "together" in Moon's ruling party's name "[Together] Democratic Party" comes from the Juche ideology textbook "Together with the Nation" from North Korea's Workers' Party of Korea. Such should be interpreted as an expression of totalitarianism. When officials from the Moon administration say they participated in democratic movements, those were not movements for liberal democracy. They are socialist activists, carefully trained in Kim Il-sung's Juche ideology and the ideology of China's Mao Zedong. They are always at the center of anti-American and anti-Japanese movements. They are deceiving people by simply saying they fought for democracy. In his autobiography, Moon stated he was delighted when the U.S. lost the Vietnam War. Moon Jae-in is completely anti-American and a communist. Now when the Moon administration refers to democracy, we should realize that it is not liberal democracy.

It is not just one or two things that enrage the people of the Republic of Korea. First, it's been

revealed how the Moon administration impeached Park Geun-hye turned out to be fraudulent. The tablet they argued to be the main evidence of monopolization of state affairs proved to be fake and was dismissed as evidence. Also, the Chinese were enlisted to join in on the impeachment rallies and used a program called Druking to forge tens of millions of online comments to manipulate the public opinion. Although former President Park Geun-hye is being acquitted of many allegations, she is still detained and awaiting trial as the Supreme Court overturns the case.

When the Moon administration's Senior Secretary for Civil Affairs, Cho Kuk, was appointed as the Minister of Justice, Korea suffered a great deal of confusion. The people were in fear as someone who called himself a socialist became the Minister of Justice. Soon Cho Kuk's private equity fund scandal was revealed and in connection with Chinese capital and was involved in the "Burning Sun gate" of drugs and money laundering that had ties to the Chinese Mafia. This also revealed corruption in the police. And many individual cases of briberies were revealed. These were serious matters where Chinese capital colluded with a high-ranking official.

Moon's own immoralities were also disclosed: the election fraud where the Blue House intervened to make Moon's friend the mayor of Ulsan; the prosecution cover-up on his friend, Yoo Jae-soo's investigation; the incident where Woori-deul (Our) Hospital, which had supported Moon, got a preferential bank loan; the real-estate corruption scandal of Son Hye-won, a friend of the first lady, Kim Jung-sook; the Chung-joo Express Bus Terminal development bribery scandal by president Chang, who is Kim Jung-sook's acquaintance; and so on. Moon Jae-in's daughter, Moon Da-hye, emigrated to Thailand. Moon Da-hye and her husband received preferential employment and convenience of stay through the Eastar Jet corporation, causing speculation that Eastar Jet received preferential treatment from the current administration. Above all, the fact that the president's daughter emigrated to another country is a shock to the Korean people. On the other hand, Moon's son, Moon Joon-yong who is a media artist, made a huge profit by supplying software materials for elementary, middle, and high schools. It should be noted that Moon Joon-yong's company is using President Moon's home address as his company's address.

There were many problems involving national security. By adopting a de-nuclearization policy, he brought in China's solar power system and allowed his personal acquaintance to manage the business. And despite UN sanctions, he illegally smuggled in coal from North Korea. What is more shocking is the Hambak Island incident. Hambak Island is an uninhabited island located in the western sea of Korea, south of the military border NLL (Northern Limit Line). North Korean forces have entered and installed a military base on the island. The former commander of the ROK-U.S. Combined Forces Command even confirmed that Hambak Island is part of South Korea's territory. Yet, Moon said administratively it is not so. And in September 2020, a South Korean official was shot and burned by the North Korean army while on duty near the island.

When the Covid-19 pandemic broke out, the government monopolized the national distribution of masks. The government received shares from a Chinese private equity fund and gave exclusive rights to distribution of the masks to Geo-Young, a company from tax haven Malta. Geo-Young's Chairperson Cho Sun-hae is the chairperson of the board of the Sookmyung Cultural Foundation while the Minister of Interior and Safety, Jin Young, is a director of the foundation. Lee Eui-gyung, the Minister of Food and Drug Safety, is a former Sookmyung Women's University professor. Also, Moon's wife, Kim Jung-sook graduated from Sookmyung Girls' High School. As the government was monopolizing the distribution of masks, when the mask supply became scarce, Assemblyman Park Jung of the Democratic Party sent 3 million masks to China based on his connection to Song Seung-min of the Chinese Communist Party.

In August 2019, a mother and son who were North Korean defectors starved to death in Seoul. They received governmental assistance in order to settle in South Korea. So, it was unimaginable and appalling that these defectors had starved to death. It was a result of government negligence.

In November 2019, two North Korean defectors were sent back to North Korea against their will. This was an act of ignoring the human rights of the North Koreans, which only the Chinese Communist Party would do. As North Korean defectors rallied to object to such an act, 48 people were arrested and two were imprisoned. Moon claims he is a human rights activist, but he is not. If one reviews the cases he took when he was an attorney, most of them were anti-state cases. First, he defended the demonstrators who burned seven police officers to death related to the Dong-eui University incident in Pusan in 1989. Second, in 1997, Moon was the defense attorney of the Korean-Chinese crew, who revolted on the deep-sea fishing vessel Pescamar and killed 11 Korean and Indonesian crewmen. Third, he defended the Yeung-nam Committee, charged as collaborators, who violated the national security laws in 1999. Fourth, he was the public defender to the Somali pirates who hijacked the Samho Jewelry chemical tanker in 2011. Moon was not a human rights attorney, but a defender of anti-national organizations.

On October 3, 2019, more than 3.5 million citizens gathered at the Seoul Gwanghwamun Plaza to call for Moon's impeachment. Since then, hundreds of citizens have continued to rally in front of the Blue House day and night for his impeachment. The April 15, 2020 general election happened during the most rampant period of the Covid-19 pandemic. The streets were empty due to consumer spending which decreased by 70-80% and minus growth. Campaigning on the streets had also disappeared. With only about a month left before the general election, the China Gate broke out. The activities of Chinese spies centered around the Confucius Institute were exposed and manipulating public opinion through fabricated online comments were also discovered. People were anticipating April 15, 2020 to be the judgment day for Moon's regime. And the Moon administration knew what would result from losing the election. Thus, they had only one choice.

They've prepared to rig the election long ago by gaining control of the chairman of the election commission and the Supreme Court justices, and seized control of the executive branch. They established a policy MOU with the Chinese Communist Party and by interacting with Song Seungmin of the Chinese Academy of Sciences, they used Tencent and Huawei. Korea imposed travel restrictions onto every country during the Covid-19 pandemic but didn't impose any to China. During the general election Chinese were employed as observers. They used the fact that it would be difficult to reveal election fraud as the last resort to survive for the Moon administration. If we do not uncover that there was an election fraud, Korea's democracy will come to an end by the Moon administration. Moon's only goal is to transform the Republic of Korea into a communist state like that of China and North Korea.
